Supply Chain

We have assessed the risk related to human trafficking and forced labour within our supplier base. Our assessment is based upon geography, the commodity purchased and supplier quality performance

The Company has 72 Approved Supplier's, 55 of which are based in the UK, 5 in the USA, 11 in Germany and 1 in Poland

In our standard procurement process, we issue purchase orders that incorporate our Terms and Conditions (T&Cs), these are further supplemented by our Corporate Responsibility Guide, which expands on our expectations and suppliers' obligations on specific topics.

Walpres expects suppliers to respect the human rights and dignity of all their stakeholders. This includes not using forced or child labour in any form, not confiscating personnel documents and not forcing payments in order to secure employment.

Training

All Employees have been issued with our Corporate Responsibility Guide, the Purchasing Department who interact with suppliers have received additional training on Modern Slavery
